# We can help ensure changes to the profession are positive

'm more than little long in the tooth. And starting to feel it in a whole lot of ways.

He's been creeping around for a while, but Father Time took up permanent residence in my psyche a couple of years ago when I entered the seventh decade of my life.

I can list a litany of epiphanies I've had since then, which really diminishes the whole idea of an epiphany. They're supposed to be like unicorns. Elusive. Rarely seen.

But mine are rapid fire. Ubiquitous.

There's the moment I realized I'd become my mother and that pillow cases must match the sheets. Maybe the scariest one happened last week when my daughter gave me advice. And it made sense.

And then there's this whole professional valuation. For 40 years, I've worked in media that's seen many a change, particularly in the last decade or so.

Unless you've lived as long as I have, you can't relate. If you're older, you're smiling. You've made it through to realization with a greater understanding and appreciation of a life and profession well lived.

That's a true epiphany.

I got close to that understanding recently when I had the incredible

honor to join a dinner of past Missouri Press Association presidents. It's held every year (barring a pandemic pause). Its only purpose — as is the case every year — is to foster camaraderie. Some in attendance were much younger than me, but some had already cycled through the angst I'm experiencing.

All have run, or are running, news organizations big and small. And they've done it with incredible success. They are icons in their communities. The proliferation of the internet hasn't changed that.

They were, and still are, leaders.

And they've earned every line on their face.

Don Warden was there. He and his brother Tom bought out their parents' shares of the Gasconade County Republican in 1977 and became sole owners. Don's son Dennis was at the dinner too. He now owns The Republican, the Maries County Advocate and Osage County's Unterrified Democrat. Incredible growth.

Trevor Vernon and his dad, Dane, Vernon Publishing there. includes *The Advertiser* in Eldon. The Index in Hermitage, Tipton Times and the recentlyannounced acquisition of a group of publications at the Lake of the Ozarks.

That latest acquisition speaks volumes. They bought it from Gannett. Talk about flipping the model of the last few decades.

Like I said, present company excluded, this was a guest list of Icons.

As I drove home from the dinner. I had yet another epiphany ... one of those baby ones again, not the big one I'm looking for.

This one had me resolved to appreciate my past 40 years in this business of newspapering.

It's a noble profession with all its delivery vehicles. It's not what is was four decades ago and it's not what it will be for the next generation of leaders.

Still, I'm proud to be a part of it and humbled by the company I kept at that dinner.

# Nancy Gaines

Nancy York Gaines, 87, of Rock Port, formerly of Fairfax, died Aug. 12, 2021.

In 1951, she was one of the first women admitted to the Linotype School at the University of Missouri in Columbia.

After schooling,

she was hired by the *Fairfax Forum* as a linotype operator.

She married Bob Gaines in 1953 and they made their home in Fairfax all their married life.

In 1979, they purchased the *Fairfax Forum* and operated it for 19 years, until 1998.

Survivors include two cousins, Marjorie Sowards and Herb VanVactor, both of Stanberry; and numerous friends. Campbellsville, Ky.

Max Heath, 75, of Campbellsville, Ky. well. died July 28, 2021. Many newspaper

people in Missouri and throughout the country know Heath for the work he did with the National Newspaper Association, specifically helping others with questions about the U.S. Postal Service.

Heath served 35 years as chair of the Postal Committee of the National Newspaper Association and wrote a

monthly Postal Tips column for Publisher's Auxiliary. He was named to the Postal Service Mailer's Technical Advisory Committee representing NNA from 1989 to 2017.

In addition to his work helping other newspapers, Heath had a lengthy career in journalism, including 22 years as executive editor for 54 weekly and daily newspapers in 13 states. For 23 years he was circulation director as



In addition to his wife, Ruth, and son. Jason. he is survived



**Warrensburg** — The *Star-Journal* is returning to publishing twice a week with the return of a Tuesday edition on Sept. 14, after more than a year as a weekly publication. The newspaper will also continue to publish on Fridays.

The addition of a publishing day for the printed newspaper was made possible by the support of area advertisers and subscribers who continue to support their newspaper, staff said.

"Ever since the *Sedalia Democrat* took over ownership of the *Star-Journal* in October, the most frequent question we receive is about additional publication days. Due to the numerous requests and positive community feedback about the paper, we've decided to make the change," Publisher Will Weibert said. "Our whole team is excited to continue our promise of improving the *Star-Journal*, and bringing back the Tuesday edition is the next step."

**Ste. Genevieve** — After 121 years, the *Herald* announced in late July it would be moving its offices ... next door. Since 1900 the newspaper had been located at 330 Market Street but at the end of July announced it would be moving less than 100 feet to 316A Market Street. That week's edition was published without interruption, although the newspaper's offices had to be closed for two days.

With the move, the *Herald* will remain on the courthouse square in downtown Ste. Genevieve. The building the newspaper formerly occupied is set to become part of the neighboring Ste. Genevieve Museum Learning Center.

Greg Hoskins, president of Better Newspapers, which has owned the *Herald* since February 2020, said it was important to keep the newspaper in the downtown district. "We are confident the Herald will continue to provide the community with outstanding service for many years to come."

**Neosho** — The *Neosho Daily News* and the *Aurora Advertiser*  are under new ownership with both being purchased by Sexton Media Group, which also publishes the *News-Dispatch* and the *River Hills Traveler*. Sexton Media Group is owned by Jimmy and Rhonda Sexton.

Plans for the newspapers include merging the *News-Dispatch* and the *Daily News* to operate solely as the *Neosho Daily News*. Offices for the new publications under Sexton ownership will be moved to 212 E. Main St., across from Neosho City Hall.

Jimmy Sexton said he and his wife are proud to continue the tradition of family ownership of one of the city's oldest businesses. "The *Neosho Daily News* has a cherished history of promoting people, businesses and organizations that make Neosho and the surrounding communities such a wonderful place to live and do business."

**Moberly** — Westplex Media Group, owner of the *Montgomery Standard*, agreed to purchase the *Moberly Monitor-Index* from Gannett Co., Inc., effective Sept. 1. It is Westplex's fourth community newspaper.

Westplex is owned by Tim Schmidt, who founded the company in 2018 when he purchased *The Standard* from John and Donna Fisher. Schmidt added a second weekly newspaper in October 2019 when he acquired *The Warren County Record* from the Missourian Media Group based in Washington. In August 2020, the company acquired the *Mexico Ledger* from Gannett.

"We are excited and honored about the opportunity to expand our family-owned company to Moberly and Randolph County," said Schmidt. "The *Monitor-Index* has a proud history and we feel this is a natural fit to grow our company. We will work hard to publish a newspaper that the community can be proud of. We feel the newspaper industry has a bright future."

The *Moberly Monitor-Index* will continue to print Wednesdays and Saturdays, with distribution through the post office.

**Camdenton** — Vernon Publishing, Inc. has agreed to acquire a group of publications in the Lake of the Ozarks region from Gannett Co., Inc. The publications being acquired include the Lake Sun, Lake of the Ozarks Real Estate, BOATS magazine, Lake Leader, Lake Lifestyles Magazine, and Vacation News.

Vernon Publishing also publishes *The Advertiser* in Eldon, *The Index* in Hermitage, and *The Tipton Times*. The publishing company is owned by the Vernon family; Dane, Sharene, Molly and Trevor, who also serves as mayor of the city of Eldon. The transaction is expected to close on September 1.

"We are excited for the opportunity to publish this group of publications around the Lake of the Ozarks," said Trevor Vernon. "I have great memories of growing up on and around the lake. We think these publications are a natural fit with the others we currently own. The future of these publications and the area is looking bright."

**Rolla** — The *Rolla Daily News* and *Kirksville Daily Express* are among five publications purchased by Phillips Media Group from Gannett Co., Inc., effective Sept. 1. Phillips also purchased *The Big Nickel* in Joplin and the *NEMO Trader* in La Plata, two shopper publications in their respective markets, as well as the *Baxter Bulletin* in Mountain Home, Ark.

Phillips Media Group operates Missouri newspapers in Bolivar, Buffalo, Hannibal, Marshfield, Ozark, Sedalia, Stockton, Warrensburg and West Plains, and a printing plant, Nowata Printing Company in Springfield. The company also owns two other newspapers in Arkansas and one in Quincy, Ill.

Jim Holland, president of Phillips Media Group, said, "We are excited to bring these publications into our group. We believe we have the expertise to effectively operate publications in these markets, putting out products that will be valued by the respective communities."

# Show-Me the beef and how it's processed

issouri is known for many things — its state parks, its gorgeous rivers and bluffs, its football (GO CHIEFS!) and basketball teams. One of those pillars of its fame is its agriculture production. The farms full of corn and soybeans waving in the

August breeze. The baby sheep, goats and cows in the spring. All contribute to the image of this state.

Along with that, however. comes the other end of agricultural production the industry that brings us fresh meat. That is a facet of Missouri's economy that isn't as easy to talk about. The last state fair month brings lots blue-ribbon animals that kids take a lot of pride But that's often where the story ends. From that point on, the subject is fraught with much conflict

and not going to be the focus of this column, except for the fact that there were interesting developments last month nearby regarding the First Amendment rights of journalists to cover this subject.

To make a long story short, Missouri has had a law since 1992 regulating the ability of persons to enter an "animal facility by false pretenses for the purpose of performing acts not authorized by the facility," among other acts prohibited by the law. An animal facility was broadly defined in Section 578.405 as any facility

involving the "use of animals." That law classified such acts as a Class A misdemeanor, with other crimes of greater magnitude included in that law classed as high as a class B felony.

The massive tort reform bill passed by the Missouri legislature

in 2014 included significant changes to this law. It added that. effective in 2017, the director of the department agriculture could investigate any violation of the statute and take action for enforcement of the statute and the attorney general and the highway patrol were given authority to assist in the investigation.

As one of only five states (also including Montana, North Dakota, Arkansas, and Alabama) where such acts include a potential criminal charge,


Missouri has not recently seen any significant "whistleblower" efforts involving either journalists or citizens reporting from inside a packing plant or other similar facility on what are believed to be unlawful or inhumane practices. Does this law hinder the First Amendment rights of citizens? Can a business use a law like this to shut down criticism of its operations? States have had few challenges to such laws, but in the last month, two cases have arisen that could portend a shift in the winds coming.

On Aug. 9, the 8th Circuit Court

of Appeals, which includes Missouri, issued an opinion in a case involving a challenge to the Arkansas law which created a civil cause of action for those who exposed abuse to animals in such operations. The appellate court first reversed an underlying Arkansas circuit court opinion dismissing a lawsuit filed by The Animal Legal Defense Fund (and others) arguing that the Arkansas law was a violation of First Amendment rights. The next day, another panel of 8th Circuit Appellate judges held that a similar Iowa law properly prohibited persons from using false pretenses to gain employment at such facilities but held other parts of the law were unconstitutional. Both opinions contained significant dissents that leave room for further challenges in those states.

And then on Aug. 19, the 10th Circuit Court of Appeals issued its opinion upholding a Kansas district court opinion which declared that state's law on this subject unconstitutional and prohibiting its enforcement. "... [T]he statute is not limited to false speech lacking constitutional protection. Instead, it punishes entry with the intent to tell the truth on a matter of public concern." the decision said.

Given that these are three states adjoining Missouri, that would seem to put the Missouri statute in a small box with a large bullseye on it. The "Show-Me" state is likely to see significantly more attention paid to its slaughtering operations than we've seen in recent years before this challenge is over.
