

### Sunshine Questionnaire

*The Missouri Press Association and the Missouri Sunshine Coalition support open government on the local, state and national levels. The MPA and the MSC also support efforts by the Legislature to strengthen open meetings and open records required by the Missouri Sunshine Law (Chapt. 610 RSMo.).*

*In late September the MPA and the MSC surveyed candidates running for the Missouri Senate and the Missouri House of Representatives. Here are the questions posed to candidates. The accompanying answers are from candidates who had responded by Oct. 22.*

1. Should not-for-profit organizations in Missouri that receive substantial amounts of public funds be subject to the Missouri Sunshine Law? **Yes No**
2. Should closed meetings of a public governmental body be required to be tape-recorded for future reference after the closed-meeting issue is resolved? **Yes No**
3. When a citizen sues a public governmental body for violation of the Sunshine Law, the citizen may win the lawsuit, but not be reimbursed attorney fees. Should the public body or public official be required to pay the citizen's attorney fees if the public body or public official loses the case? **Yes No**
4. Should names and addresses of candidates for employment at public governmental bodies be available to citizens? For instance, should applicants for school superintendent positions and city manager positions and county public works director positions be open to the public? **Yes No**
5. When a police chief, superintendent of schools or city manager is dismissed from his or her job, should the reason for discharge be available to the person's future employers? **Yes No**
6. Should the reason for discharge be made available to taxpayers? **Yes No**
7. Should Charter Schools which receive taxpayer funding be required to publish annual statements of financial condition in a local newspaper, just like public schools are required to do? **Yes No**

In the wake of the financial crisis of 2008-2009, should banks again be required to publish this information regularly so bank customers may judge for themselves if their deposits are safe? **Yes No**
